

1. SUBJECT

This Tariff shall apply to the activities listed below:

- Assessment of Personal Protective Equipment (hereinafter referred to as "PPE") for the compliance with the requirements of Regulation EU 2016/425 (hereinafter referred as REGULATION) Module B;
 - For III category PPE, production control in accordance with the procedures MODULE C2 or MODULE D.
- The amounts are VAT excluded.

2. GENERAL NOTES

The items in the tariff are related to "standard" situations and may be subject to changes in the case ITALCERT finds elements of particular complexity or possible simplifications due to synergies in case of multiple certifications.

The amounts for the activities carried out by ITALCERT are explained as usual one by one in an economic offer transmitted in documented form (email, ordinary mail).

4. EU TYPE CERTIFICATE**4.1 Certification request**

The case applies to the application for certification of PPE which requires the issue of a new certificate.

4.1.1 Analysis of technical documentation for each technical file or family of PPE, including visual examination of one or more sample of the PPE	€ 700,00
4.1.2 Additional analysis of technical documentation following the first evaluation (if applicable)	€ 90,00 / h
4.1.3 Type tests	To be quoted on the tests provided for
4.1.4 Issue of the EU-type certificate (Italian/English) including the test report (in Italian, if not differently agreed)	€ 700,00
4.1.5 Issue of a copy of the test report in another language	€ 300,00

NOTE 1: It is possible to reduce the abovementioned fees up to a maximum of 40% of the total compared to the amounts provided for the analysis of technical documentation and for the issue of certificates in the event that the application for certification provides for the issue of more than 3 certificates.

NOTE 2: The translation of the type-examination certificate and of the test reports in other languages other than English, it is not a duty. ITALCERT may deny any request received in this regard.

4.2 Changing of a valid EU type certificate

The event applies to the application for a modification of a valid EU certificate as a result of a new configuration of certified PPE and/or to any range extensions (such as changes to the type certified).

4.2.1 Analysis of technical documentation	Starts from € 500,00
4.2.2 Type tests (if necessary)	To be quoted on the tests provided for
4.2.3 Reissue of the EU type certificate	€ 400,00

NOTE 1: The amounts related to the analysis of the documentation may be quoted for an amount higher than € 500.00 and up to a maximum of € 1.000,00 according to the complexity related to the evaluation of the pre-existent documentation. Any applications about variants of PPE already certified where the manufacturer requires to be able to omit some tests on the base of analogies between certified PPE and new products fall within this case.

4.3 Update of a valid EU type certificate

4.3.1 Update following changes of the manufacturer's data (name, address)	€ 200,00
4.3.2 Update following the sale of a business unit to another manufacturer	To be quoted according to the number of PPE certified

NOTE 1: The update of the EU certificate following the sale of a business unit is not an act due by ITALCERT, which has the option not to update the certificate.

4.4 Renewal of the EU type examination certificate

4.3.1 Review of technical documentation	€ 400,00

4.5.1 Issue of a letter of release, following modifications of PPE certificates without the update of EU type certification, including the assessment of the updated technical documentation.	€ 90,00 / h (minimum 3 hours)

4.6 OBM (Own Brand Manufacturer)

Application for the issue of an EU type examination certificate according to the procedure written in RfU PPE-R 00.047.

4.6.1 Analysis of technical documentation	Starts € 500,00
4.6.2 Issue of the EU type certificate	€ 400,00

NOTE 1: It is possible to reduce the abovementioned fees up to a maximum of 40% of the total compared to the amounts provided for the analysis of technical documentation and for the issue of certificates in the event that the certificate of the original manufacturer has a residual validity less than 4 years.
